

Negligence Of Fellow-servant. --Where an employer has provided competent workmen to remove loose stone left in a rock cutting after blasts, and their foreman, whose competency is unquestioned, has failed after an effort to do so to remove a large stone from the top of one bank of the cutting after the days blasting, the employer is not liable to one of the workmen, whom he directed to go to work in the cutting, for damages for an injury occasioned by a fall of the stone, within a few hours afterwards, since the employer had the right to intrust the details of the work to his foreman and the other workmen, and if the accident was the result of some negligent act of commission or omission in their midst, the negligence was that of a fellow-servant, which risk the injured employee assumed in entering upon the employment.
